TERMS OF REFERENCE :- The Terms of Reference (ToR) of the Community Convergence Committee are as follows :-

The Community Convergence Committee will be a platform for involving community members in identifying and prioritizing a development related works of social relevance in consultation with other members.

Scope of work of Community Convergence Committee:

- 1) Identification of last mile connectivity that link villages to rural markets
 - o Roads
 - o Ropeways or
 - o Small bridges
- 2) Community Convergence Committee shall recommended the list of such identified works to the DC and Chairman, BDU and PD DRDA through BDO which can be included in the Annual Action plans of MBDA
- 3) The Community Convergence Committee should meet at least once a month and minutes of the Meetings to be shared with the DC and Chairman, BDU and PD DRDA.
- 4) The member of Community Convergence Committee may be involved in implementing Megh Lamp and SRIDI Projects by involving local implementation committee to ensure effective community participation.
