No.SWGHA/SUP/ALLOCATION OF RICE/NFSA2013/Pt.2/2015\_\_\_ : As per the of the Director, FCS & CA, Meghalaya, Shillong the Undersigned is pleased to release additional allotment of rice and pulses (dal) under Pradhan Mantri Garib Kalyan Anna Yojana (free of cost) to the beneficiaries of Antyodaya Anna Yojana (AAY) and Priority House Hold (PHH) card holders. Under this scheme, rice will be distributed in the scale of **5kg/beneficiary/month for 1(one) month i.e., for April' 2020 and pulses (dal) in the scale of 1 kg/card/month for 2 (two) months i.e. for April and May' 2020 for AAY and PHH households** and delivery of the said foodgrains will start from **20<sup>th</sup> April' 2020**. It may be mentioned that as per NFSA, 2013 rice and pulses will be delivered free of cost to the doorstep of each F.P. Shop Centres by the concerned Wholesalers for onward distribution of ration to the beneficiaries.

In this regard, all the Block Development Officers of Rerapara, Betasing and Zikzak Block under South West Garo Hills district are hereby directed to monitor the distribution of the same in their respective Blocks (*link to F.P. Shop Centres <http://epds.nic.in/ML/epds/#>*) so that the objective of providing free ration is achieved in rural areas. For easy access and availability of stocks, all F.P. Shop dealers are also directed to display stock signboards and maintain the timing of opening of F.P. Shops (*i.e., from 9:00 AM to 4:00 PM*) on working days except Sunday or till stocks lasts.

All PDS Wholesalers are directed to cooperate and complete the process of doorstep delivery at the earliest so that under privilege households can be benefitted.
