No. SWGHA/AMP/SUP/NFSA/2013/340. In pursuance of Order issued by the Directorate, Food Civil Supplies & Consumer Affairs Department, Govt. of Meghalaya vide letter No. PMU.5/2014/PT.5/480 Dated 24th April' 2020 regarding Targeted Public Distribution System. It has come to our notice of the Undersigned that eligible beneficiaries are being deprived of their monthly food-grains quota for various reasons in certain parts of the district. As per guidelines under the National Food Security Act' 2013, I, do hereby instruct all Fair Price Shop Dealers that:

1. Beneficiaries who does not possess a ration card but their names appearing on the transparency portal shall not be denied of food-grains.
2. All beneficiaries whose details are available on the portal <http://epds.nic.in/ML/epds/?publicreport=NFSAREPORT#> should not be deprived of their food-grains quota.
3. Food-grains should not be deprived if there is an expired HOF (Head of Family), the ration card by default will automatically go to the next kin (family member) after submission of death certificate and necessary verification will be done by the supply office expeditiously.
4. Beneficiaries not to be deprived of their quota due to some typing error and spelling mistakes reflected on the Database/Portal will be corrected immediately on producing valid documents.
5. FPS Dealers not to deprive the beneficiaries from collecting food-grains for not having an Electoral Photo ID Card (EPIC) and shall not insist on the produce of EPIC card.

Fair Price Shop Dealers violating these measures shall be prosecuted as per provisions of the National Food Security Act' 2013 and other relevant provisions as applicable.
