



**ORDER**

Dated Ampati, the 1<sup>st</sup> May, 2021

No. PA/DCA/DTFI-COVID-19/65/Prt.II/2020/15, Whereas, Government of Meghalaya is exercise of powers conferred Under Section 2, 3 & 4 of the Epidemic Disease Act, 1897 has constituted. The Meghalaya Epidemic Disease, COVID-19, 2020 and Amendments thereof for Containment of outbreak of COVID-19.

And Whereas, there has been detection of positive COVID-19 cases under Betasing PHC due to recent high risk and low risk contact with the COVID-19 positive cases, vulnerable and affected areas require aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public against any possible spread of COVID-19.

Therefore, it is necessary to declare the Father's residential compound of **St. Claret School** under **Betasing PHC** as Containment areas so as to restrict unregulated entry and exit movement on site with the following measures for due compliance by the public.

1. No persons/public shall be allowed to move into the containment area and inhabitants within the Containment areas shall not move out.
2. All the inhabitants within the containment areas shall strictly remain inside their home.
3. No gatherings, events, functions whatsoever of any nature and forms shall be allowed.
4. No Social, Political, Religious, Economic activities are allowed.
5. All Private Institutions located within the boundary of the containment areas is hereby closed forthwith, till further Orders.
6. Smt. W.R.G.Momin, MCS, Executive Magistrate & BDO Betasing C&RD Block shall be the supervising Officer which is declared as Containment areas under Betasing PHC.
7. This order shall not apply to health workers and essential workers.
8. MBOSE exams in the St. Claret School shall continue as per the schedule with necessary precautions and observing health protocols related to COVID-19.

**ANY VIOLATION OF THIS ORDER SHALL ENTAIL PROSECUTION UNDER THE PENAL PROVISION OF DISASTER MANAGEMENT ACT, 2005 AND I.P.C.**
