**ORDER**

**Dated Ampati, the 03<sup>th</sup> May, 2020.**

**NO.ACS/EXCISE-13/2007/6:-** In pursuance of the Order No. ERTS(E) 26/2020/24, dated Shillong, the 2<sup>nd</sup> May, 2020 and No. POL.75/2020/Ptl/23 dated 2<sup>nd</sup> May, 2020 and in compliance with the guidelines of the Ministry of Home Affairs, Government of India Order No.40-3/2020/DM-1(A) dated 1<sup>st</sup> May, 2020. The undersigned hereby directed to open IMFL "OFF" Shops, Canteen and Bonded Warehouse w.e.f 4<sup>th</sup> May, 2020 from 8:00 am to 1:00 pm on the permitted days, subject to compliance of the following guidelines:-

- 1) That, the Wine shops shall be responsible, by deploying their staff, to ensure maintaining Social Distancing of at least 6 feet from each other and also ensure that not more than 5 persons are present at one time at the shop.
- 2) All directions issued by Health & Family Welfare Department, Govt. of Meghalaya with reference to COVID-19 situation should be strictly followed.
- 3) That, wine shops should work with bare minimum staff. All staff should compulsorily wear masks and provide hand sanitizers to customers and staff, while handling the bottles and cash.
- 4) To strictly avoid overcrowding, staff of a particular wine shop shall direct the customers to other nearby wine shops in case of overcrowding.
- 5) That, the wine shops will extend full cooperation to District Administration, Police, Excise etc.

**\*Failure to comply with the above guidelines by any wine shop shall be liable for action as per provisions of relevant Acts and Rules.**
