ORDER UNDER SECTION 144 CrPC

Dated Ampati, the 9th April, 2020

No. PA/DCA/DTFI-COVID-19/65/2020/117, In continuation of this Office Order vide No. PA/DCA/DTFI-COVID-19/65/2020/102 Dated Ampati, the 3rd April, 2020, in view of the prevailing situation concerning COVID-19 in the country and globally,

Whereas, to put in place preventive measures and to steps to ensure social distancing so that the pandemic of COVID-19 does not spread to South West Garo Hills District and Meghalaya, by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department;

Now, therefore, I Shri. Ramakrishna Chitturi, IAS, District Magistrate, South West Garo Hills District, Ampati in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Disease, COVID-19 Regulations, 2020 do hereby extended the **CURFEW** and **PROHIBIT** as under:

1. Operations of all weekly markets, regular markets, commercial and financial establishments in South West Garo Hills District.
2. Assembly or gathering of 5 (five) or more persons in all public places, premises, commercial and residential localities beyond the Individuals households.
3. Operational of all forms of **PUBLIC TRANSPORT** in entire district.
4. Movement of all **PRIVATE VEHICLES** and Autos (except those with valid car passes issued by undersigned and Exempted categories listed above).


This Order will **NOT** be applicable to:

1. Security Forces, Medical Teams and Essential Services.
2. Pharmacies
3. Shops dealing with food, groceries stores, fruits & vegetable, milk, Meat fish, animal feed & fodder, seeds, fertilizers, pesticides and shops of agriculture machinery, its spare parts & veterinary hospitals, dispensaries and clinics both in public and private sector.
(Timing 7:00 A.M. -1:00 PM each day).
4. MePDCL, PHE & PWD
5. Food & Civil Supply Deptt. And FCI Staff.
6. Telecom, Telegraph Communication & IT Services, NIC
7. Print & Electronic Media.
8. Banks & ATMs, Treasuries.
9. Postal Services.
10. Agricultural & Animal Husbandry Activities.
11. Vehicles carrying Essential Commodities, food items, medical equipments or other good, Home delivery, Community delivery vehicles.

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with effect from **06:00 AM of 10th April, 2020** and shall remain in force until further orders.
