No. PA/DCA/DTFI-COVID-19/65/2020/297, In partial modification of this order No. PA/DCA/DTFI-COVID-19/65/2020/290 Dated Ampati, the 8th May, 2020 and in pursuance of the order NO. POL.75/2020/Pt-1/29 Dated 9th May, 2020 issued by the Political Department, Government of Meghalaya- the following additional activities are permitted in the District from 11th May, 2020.

1. **Within the District:** All shops except tea stalls, restaurants and Dhabas.
(Timing: 7:00 a.m to 1:00 p.m.)
 - (a) Stationery Shops.
 - (b) Auto Spare Parts Shops.
 - (c) Authorised car wash units.
 - (d) No hawkers on the crowded Junctions and Main Roads.
2. Operation of all forms of **PUBLIC TRANSPORT** within the district will be increased to 50% to be regulated by District Transport Officer. All vehicles to operate at 50% alternate seating arrangements. Autos Rickshaws/Tempos on Odd/Even basis to continue.
3. Private transport will be permitted to operate **within the district** to the extent of 50% and will ply on Odd/Even basis from **9:00 AM to 5:00 PM**. Odd Registration Number Odd day and Even registration Number Even day. Four-wheeler vehicles will have maximum two persons besides the vehicle driver and for two-wheelers, pillion ride is not allowed.
4. Wearing of Mask and Maintaining **Social** distancing is mandatory.
From 7:00 P.M to 6:00 A.M Everyday will be TOTAL CURFEW in entire district of South West Garo Hills, Sunday will also be closed.


In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with effect from **6:00 A.M of 11th May, 2020 and shall remain in force until further orders.**
