



ORDER

Dated Ampati, the 23rd April, 2020

No.PA/DCA/DTFI-COVID-19/65/2020/ 187 : In pursuance of the Order issued by the Ministry of Home Affairs, Govt. Of India vide Order No.40-3/202/DM-1 (A), dtd. 15th April, 2020 at Sl. No.6 (ii) and as per meeting held on 23/04/2020 in the office chamber of the Deputy Commissioner, Ampati, Block Development Officers along with the Horticulture Officers, Ampati- the undersigned in hereby allowed to operate harvesting and transportation of arecanut in the district with immediate effect subject to the following terms and conditions:


1. Harvesting and transportation of Arecanut will be allowed exclusively for indigenous growers/arecanut grower's association/Local Traders in the villages. Traders beyond the District/State borders shall be strictly prohibited in the operations.
2. All buyers shall submit their names and vehicle details to District Horticulture Officer and respective Block Development Officers for record maintenance and smooth facilitation of all operations.
3. The farmers/traders shall identify the buyers, the vehicles intended for transportation and thereafter submit their details to BDOs for issue vehicle permit within the District only and for outside the District the Deputy Commissioner/Addl. Deputy Commissioner will issue of vehicle permits based on the recommendation by the concerned BDOs.
4. Timing of transportation shall be confined from 7:00 a.m. (morning) to 5:00 p.m. (evening). Operations/activities beyond 5:00 p.m. shall be prohibited.
5. Only those vehicles for which permits have been issued by the District Administration/Block Development Officer(s) shall be used by the traders while purchasing and transporting the arecanuts to the designated locations.
6. The buyers/traders shall follow the transportation route for designated places i.e. Mirjumla in South West Garo Hills District and Phulbari in West Garo Hills District.
7. The District Horticulture Officers will coordinate with District Horticulture Officer West Garo Hills District to transport the arecanut to Phulbari.
8. Report on arecanut quantity procured from various sources/ locations and transported to the storage locations shall be furnished daily to Block Development Office.
9. All guidelines regarding social distancing, wearing of mask/handkerchief etc shall be followed during harvesting, transporting and other activities.

This order is valid only within the jurisdiction of South West Garo Hills District.
