**ORDER**

Whereas, in view of the outbreak of the Covid-19 (Corona virus) across the world and in India and with a view to ensure that person(s) coming / returning from outside the state (ie. especially from states where positive cases have been detected), do not venture out from their house, it is mandatory that such persons are required to isolate themselves at home in a safe distance from other members of the family for a minimum period of 14(fourteen) days as a precautionary measure as advised by the Medical authorities.

If any such person violates this order and venture out from his/her house without the permission from the authority concerned, action shall be taken **U/S 188 /269 /270 IPC** against any such person(s).
