ORDER

Dated Ampati, the 24th April, 2020

No.PA/DCA/DTFI-COVID-19/65/2020/192: In pursuance of Order issued by the Government of Meghalaya, Political Department, Shillong vide order No. POL.75/2020/PtI/19 Dated Shillong, the 23rd April, 2020 and in continuation of earlier vide office Order No. PA/DCA/DTFI-19/157 Dated Ampati, the 19th April, 2020 issued by this office, the following activities are exempted from the purview of curfew. Strict observance and compliance of protocols and advisories of Government of Meghalaya in respect to maintaining social distance of atleast one metre, covering of nose and mouth with handkerchief/mask/scarf and no spitting in public places and proper hygiene practices are to be ensured.

1. **Commercial and Private Establishments, as listed below, will be allowed to operate.**
 - a) Shops dealing in Essential Goods.
 - b) Courier services for essential goods.
 - c) E-Commerce Operations in goods.
For the above, essential goods is included in Annexure -1.
 - d) Common Service Centres.
 - e) Services provided by self-employed persons, e.g. electrician, IT repairs, plumbers, motor mechanics, and carpenters.
 - f) Shops for repair of trucks on National/State Highway within South West Garo Hills District.
 - g) Hardware stores for providing items like CGI Sheets, Cement etc. that are used for construction including transportation of the same with prior permission of the undersigned.
 - h) Electrical Shops.
2. **Industries/Industrial Establishments (both Government & Private), as listed below will allowed to operate**
 - a) Food processing industries in rural areas i.e. outside the limits of municipal corporations and municipalities including rice mills and mustard oil processing.
 - b) Brick kilns in rural areas i.e., outside the limits of municipal corporations and municipalities. However, necessary permission would be required from the undersigned for operation of Brick Kilns.
3. All agriculture and allied sectors activities like farming operations including livestock Farming, Poultry, Fishery and Hatcheries, Collection, Processing and Distribution of Milk and Milk Products, mandis by APMC, procurement and marketing of agricultural produce, Custom Hiring Centres, cold storage and warehouses. Manufacturing, packaging and marketing.
4. Transportation of Arecanut subject to conditions as notified by District Administration vide order.

5. Veterinary Hospital, Dispensaries, Clinics, sale and supply of medicine and vaccines.
6. MNREGA works are allowed with strict implementation of social distancing and uses of face mask/handkerchief. Priority is to be given to irrigation and water conservation works.
7. Construction Activities: Construction of Roads, irrigations projects, buildings and all kinds of industrial projects, including MSMEs, in rural areas, i.e., outside the limits of municipal corporations and municipalities: and all kinds of projects in industrial estates.
Strict observance of SOP (Annexure-3) shall be followed for these activities.

8. Quarrying of chips and aggregates including their transportation with prior permission of the undersigned.

This order shall comply with immediate effect and continue until further orders.


