ORDER UNDER SECTION 144 CrPC

No. PA/DCA/DTFI-COVID 19/65/2020/218, Whereas, in pursuance of Order issued by the Principal Secretary to the Government of Meghalaya vide No. VET (G)/17/2012/73 Dated Shillong, the 27th April, 2020;

And Whereas, in view of unusual mortality of Pigs in the District of Dhemaji, North Lakhimpur, Biswanath, Dibrugarh, Sivasagar and Jorhat of Assam and in the District of West Kameng, Papum-pare, Lower Siang, Upper Siang, East Siang, Lepa-Rada, Namsai and Changlang of Arunachal Pradesh;

Now, therefore, I Shri. Ramakrishna Chitturi, IAS, District Magistrate, South West Garo Hills District, Ampati in exercise of the powers conferred upon me under section 144 Cr. P.C do hereby order the following measures for strict compliance to prevent spread of the disease in South West Garo Hills District.

1. Transportation of Pigs from other States into the South West Garo Hills District is hereby stopped until further order.
2. All Government pig farms, private pig farms and pig farmers should take adequate measures for strict hygiene and bio-security such as disinfection of the farms, equipments etc. and restricting entry of any outside persons into pig farms. Detailed advisories can be downloaded from the <http://megahvt.gov.in/>
3. It is advised that people should consume pork only after adequate cooking (above 70°C for at least 20 minutes).
4. Sign of high fever in pigs and any abnormal mortality of pigs should be brought to the notice of District AH & Veterinary Officer/Block AH & Veterinary Officer.

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with immediate effect and shall remain in force until further order.
