ORDER UNDER SECTION 144 CrPC

Dated Ampati, the 19th December, 2019

No. PA/DCA/ROAD SAFETY/29/Prt.I/2017/42: Whereas, during the course of discussion on traffic situation in Ampati Market area it was emphasized by all stakeholders that it was caused due to wrong parking and parking without a driver for a long period of time especially a tempo and auto rickshaw in and around the Ampati Market tri junction which are leading to inconvenience to the general public.

And whereas, it is further reported that most of the commercial and private vehicles are illegally parked and parking in both sides at **No Parking Zone** area in Ampati market tri junction causing obstruction of free movement of vehicles.

Whereas, in order to avoid traffic congestion and in the interest of the general public, the temporary parking lot has been arranged near the Ampati Super Market for Bus, Tempo & Auto Rickshaw and Private Vehicles till the permanent parking space is available. The temporary parking lot for Pickup Truck and other similar type of vehicle has been arranged at GHADC land opposite to old SBI Ampati.

Further, the undersigned hereby order all the general public to cooperate with the District Administration and if anyone violates they will be prosecuted as per relevant sections of law.

In view of the above, I am of the opinion that there is sufficient ground for promulgation of Prohibitory orders Under Section 144 CrPC.

Now, therefore, I Shri. Ramkumar S., IAS, District Magistrate, South West Garo Hills, Ampati in exercise of the power conferred upon me Under Section 144 CrPC do hereby promulgate the prohibitory order for wrong parking, both sides parking and parking without a driver for a period of ten minutes or more in **NO PARKING ZONE** at Ampati Bazaar area which means 50 metres on all sides of the junction.

Considering the traffic situation at Ampati Market area, this order has been passed ex-parte and will enforceable with immediate effect and will remain until further orders.
