ORDER U/S 144 CrPC

Dated Ampati, the 24th March, 2020

No. PA/DCA/DTFI-COVID 19/65/2020/39, Whereas, in view of the prevailing situation concerning COVID-19 in the country and globally,

Whereas, to put in place preventive measures and awareness, to identify and take more stringent steps to ensure social distancing and home quarantine so the pandemic of COVID-19 does not spread to South West Garo Hills District and Meghalaya, by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department;

Now, therefore, I Shri. Ramakrishna Chituri, IAS, District Magistrate, South West Garo Hills District, Ampati in exercise of the power conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Disease, COVID-19 Regulations, 2020 do hereby promulgate **CURFEW** in South West Garo Hills District with effect from 09:00 PM today the 24th of March, 2020 up to 6:00 AM the 28th of March, 2020.

This Order will **NOT** be applicable to:


1. Security Force
2. Medical Teams on duty
3. Wholesale & Retail Pharmacies
4. Police & Armed Force
5. Fire & Emergency Service
6. MeECL
7. Food & Civil Supply Department
8. FCI
9. Public Works Department (PWD)
10. Public Health Engineering (PHE) Department
11. Meghalaya Directorate of Dairy Department.
12. Telecom, Telegraph, Communications & IT Services
13. Print and Electronic Media.
14. All other Essential Services including Health Services, LPG Deliveries, Banks & ATM, online food delivery, online service delivery, courier services.

Also, movement of vehicle carrying commodities, security forces, medical equipments & goods vehicles are also exempted. However, Drivers and attendants of the vehicle shall be subject to medical screening as per laid down protocols.

In view of the urgency of the matter this order has been passed ex parte.
