ORDER U/S 144 CrPC

Dated Ampati, the 19th March, 2020

No. PA/DCA/DTFI-COVID 19/65/2020/111: **Whereas**, in view of the prevailing situation concerning COVID-19 in the country and globally.

Whereas, to put in place preventive measures and awareness, to identify and take steps to ensure social distancing and home quarantine so the pandemic of COVID-19 does not spread to South West Garo Hills District and Meghalaya, by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department.

Now, therefore, I Shri. Ramkumar S., IAS, District Magistrate, South West Garo Hills District, Ampati in exercise of the powers conferred upon me under section 144 Cr.P.C. do hereby prohibit as under:

- 1) Operations of all markets and commercial establishment in South West Garo Hills District.
- 2) Operational of all forms of public transport including boulder transportation to Bangladesh.
- 3) Assembly or Gathering of 5 (five) or more persons in public areas and premises beyond the individual households.

This order will not be applicable to the Security Forces and Medical Teams on duty.

In view of the urgency of the matter, this order is being passed *ex parte* and it shall come into force from Midnight 20th March, 2020 and shall remain in force till Midnight of 21st March, 2020.
