ORDER U/S 144

Dated Ampati, the 23rd March, 2020

No. PA/DCA/01/DTFI-COVID 19/65/2020/14: **Whereas** it has come to the knowledge of the undersigned that emergency has arisen due to the outbreak of the Corona virus across the world including India.

And **Whereas**, I am satisfied that necessary steps are required to be taken to issue prohibitory orders to effectively enforce social distancing in order to contain the spread of the virus in the District,

Now therefore, in exercise of the powers conferred upon me under Section 144 CrPc, I Shri. Ramkumar. S., IAS, District Magistrate, South West Garo Hills, Ampati do hereby prohibit the following:

For, the period 24th – 31st March, 2020

1. Operations of all shops, commercial and business establishments is prohibited except on **Mondays** and **Thursdays**.
2. Plying of all forms of Public transport is prohibited till **31st March, 2020**.
3. Assembly or Gathering of 5(five) or more persons in all public areas, premises, commercial and residential localities beyond the individual households is prohibited except on **Mondays** and **Thursdays** with minimum of 1 metre distance.

However, Security Forces and Medical Teams on duty, Pharmacies and all essential services including Health Services, MeECL, Public Health Engineering (PHE) Department, Public Works Department (PWD), Police and Armed Forces, Fire & Emergency Service, Food & Civil Supplies, Telecom Services, Banks and ATMs are exempted.

In view of the urgency of the matter, this order is passed exparte and shall come into force with immediate effect until further order.
