No. SWGHA/DP-103/PID/2019/82, : Whereas, it has been brought to the notice of the undersigned that some individual(s)/group of persons are resorting to destruction of the Catchment areas by felling trees and killing Wildlife in South West Garo Hills district.

Whereas, such destruction of Catchment areas by felling trees and also the killing of Wildlife are likely to lead to the drying up of streams / springs, rivers etc. besides endangering wildlife

And whereas, I am satisfied that emergent steps are required to be taken to prevent such destruction of Catchment areas and Wildlife for the interest of the future generation,

Now therefore, in exercise of powers conferred upon me under Section 144 Cr.P.C., I, Shri Ram Kumar S., IAS, District Magistrate, South West Garo Hills, Ampati do hereby prohibit any activity which may lead to destruction of Catchment areas and Wildlife in the entire South West Garo Hills district.

This order shall come into force with immediate effect and will extend to the entire South West Garo Hills District and will remain inforce until further orders.

As the circumstances of the case do not admit service of notice in due time, this order is passed exparte.
