No. PA/DCA/DTFI-COVID 19/65/2020/44, This is for general information of the public of South West Garo Hills that in view of the outbreak of COVID-19 across the world as well as in India complete lockdown has been imposed across the country for 21 days. However, the general public is requested not to panic and not to resort to panic buying of essential items. Please be assured that there is enough stock of essential commodities in the district and there will be no shortage in supplies of such items. On 26th March, 2020 the shops selling essential grocery items like, rice, dal, sugar, mustard oil, etc including vegetable vendors and pharmacies will open from 10: 00 AM to 2:00 PM only. All other shops will remain closed.,

There will be regular supply of essential items so there is no need to rush for shopping. Only one member of a household may come out for shopping of such essential items and maintain a minimum distance of 2 metres from other persons while shopping. 
